- Storage operator may require a security deposit to assure unit is completely cleaned out by buyer.
- Storage operator reserves the right to set a minimum price or to adjourn sale to another time. Storage operator reserves the right to set other sale conditions which will be announced at commencement of bidding.
- Purchasers rights to any damages claim on a purchase shall be limited to the purchase price.
